We reserve the right to charge a four hundred ninety-nine (\$499) early termination fee.

If under circumstances beyond the control of Buy Rite Oil, oil becomes unavailable in the local delivery area causing the company to incur additional transportation fees or demurrage charges, the company reserves the right to pass those additional fees onto the customer.

- Customers must be on an automatic delivery basis and have a credit-approved application on file in our office.
- Customer may not combine this contract with any other offer. Senior Discounts do not apply to this offer. Any remaining credit on this contract will be used toward your next contract or future deliveries.
- This contract is only applicable to #2 HOME HEATING OIL.
- For commercial/residential accounts, prices are before any taxes that may be applicable.

Deliveries are calculated by degree-days. If an unscheduled top off is requested, the delivery must be made prior to the end of the contract period in order to receive the contracted price and **MUST** meet our minimum delivery amount of 150 gallons or fees may apply. Signature on this agreement constitutes the use of our oil strictly and no other deliveries by another company are allowed without forfeiting your prepaid plan. A \$499 fee will be applied.

- Refusal of automatic deliveries will void this contract and the cancellation fee will be incurred.
- Any fees incurred to collect monies due the Company are the sole responsibility of the customer.
